Position Objective:	To coordinate and deliver recruitment, training, assessment and support services for foster carers and kinship carers, and to provide placement matching consultation for children and young people in Anglicare's Out of Home Care OOHC programs.
	The position will work with other team members in the foster care program, to ensure an integrated service delivery model. This will incorporate the Sanctuary Model framework based strongly on the theoretical frameworks of attachment, child development and trauma theory to promote positive outcomes for children and young people.

Responsibilities:

- Coordinate foster care recruitment activities, building systems that provide prompt and informed responses to carer enquiries and effective processing of carer applications.
- Undertake Carer assessments and prepare quality assessment reports for submission to the Carer Authorisation Panel and Principal Officer.
- Coordinate and undertake Carer reviews, including the development of Carer development plans.
- Coordinate and deliver introductory and ongoing training for carers, including the delivery of therapeutic training packages for carers.
- Provide consultation to case managers and other OOHC staff on placement matching, and placements at risk of disruption.
- Supervision of Carer Support Worker
- Maintain systems to ensure all required compliance and probity checks are completed for Carer applicants and household members.
- Administrate and maintain internal and external Carer data bases.
- Work in alignment with Anglicare's values and commitment to becoming a Sanctuary trauma informed organisation.
- Work in accordance with Anglicare's overarching operational priorities and relevant policies and procedures.
- Participate in professional development activities.
