

Fire Season Foresight

A fire believed to have been started from a burnt out car at Pierces Creek, ACT was a scary and timely reminder of the importance of being ready to act quickly this fire season. The fire quickly grew to 204 hectares in size, only seven kilometres from the Canberra suburb Kambah. The SES door knocked in areas under threat to ensure that the residents were fire ready, and Anglicare Disaster Recovery was put on alert but stood down a couple of days later.

Emergency Services Australia said strong winds made conditions difficult, bringing to mind the 2003 Canberra bushfires. 23 crews, 6 helicopters, 3 bulldozers, 2 graders and an excavator were deployed to help get the blaze under control.

The Pierces Creek fire was contained but has prompted the community to ensure they are prepared for the remainder of the fire season, which this year due to the forecast of dry conditions, was brought forward by one month.

Cruise ship crisis!

On a lovely sunny autumn day in late May, DR volunteers Margaret, Garry and Vere from Batemans Bay, joined the Shoalhaven group in Ulladulla for a Disaster Recovery Training day. This is how their day unfolded.

Our scenario involved a cruise ship on fire off the coast of Ulladulla. Two types of role were played out in rotation by participants. Cruise ship passengers, having evacuated with no notice from the life boat areas, had various issues, such as no medications, limited mobility, family separation, identification papers and valuables left behind, signs of mental health or symptoms of distress. Those receiving them on shore needed to ensure everyone was registered, offered catering, hospitality, an ear to listen and endeavored to resolve the various issues passengers needed assistance with.

As passengers were to be transported by bus to another location, there was no need to organise accommodation, though many passengers needed reassurance that they would be looked after and that their issues would be resolved. The changing situation on the cruise ship, or for passengers, as the exercise progressed, added to the realism and the challenges. Thankfully towards lunchtime, we were advised that the fire on the cruise ship had been extinguished and it was being towed to Port Kembla.

It was a valuable 'realistic' training exercise and the three of us appreciated being able to join in the activities. We want to thank most sincerely the Shoalhaven organisers for allowing us to be with them on the day. They did a marvelous job putting the exercise together and assisting us all in working through the scenarios.

Thoughts from the Volunteers Conference

At Anglicare's invitation, Disaster Recovery volunteers Charles and Robyn attended the 2018 National Volunteering Conference in Sydney in June 2018. Here they share their impressions of the thought-provoking topics covered at the event.

The conference was mainly aimed at those who manage volunteers, rather than volunteers themselves. Nevertheless we learnt a lot, some of which is directly relevant to disaster recovery and some of which is of more general interest.

There was an informative session about partnerships between business and charities. There is scope to expand such partnerships, not just through donations of money and goods but also through businesses allowing employees time off to work for charity. Charities receiving government funding are often under pressure not to criticise government. However, it was widely agreed that advocacy is a core responsibility of charities – it is good to help people living in poverty but we should also advocate for policies which reduce the incidence of poverty in the first place. Anglicare, through its advocacy on behalf of the homeless and unemployed, is particularly good at this.

There was an interesting session on the United Nations' 17 Sustainable Development Goals which seek to tackle the causes in inequality and injustice around the world. Charities should link their work to the Sustainable Development Goals when seeking funding and preparing plans.

Not surprisingly, social media generated much discussion. While social media enables the rapid spread of information, it can also cause problems when large numbers of poorly prepared people turn up to assist at a disaster. It is a challenge to ensure that their skills and enthusiasm are used without putting them at risk and without causing conflicts.

Looking specifically at disaster recovery, a sobering statistic is that nearly 80% of disaster recovery volunteers are over 55. As these volunteers retire or die, how do we attract new younger volunteers?

This article barely touches the surface of the fascinating and wide-ranging issues which were covered at the conference. We urge anyone who is offered the opportunity to attend in the future to grab that opportunity.

Following months of extremely dry conditions, Australia experienced the driest September on record. Despite heavy rains in some areas during October, drier and warmer than average conditions are expected to continue during the coming months.

Warmer October days resulting in increased evaporation, and below average soil moisture all play a part in the coming season set to be one of the ten driest seasons on record. The Bureau of Meteorology has raised the likelihood of an El Nino to 'El Nino Alert', indicating an increased risk of bushfire and dangerous conditions.

As this bushfire season continues and we hear of the horrific fires in California, we are reminded of the significance of Disaster Recovery and thank you for being part of such a valuable team.
